

Application under Order 6, Rule 17 read with section 151 CPC for seeking amendment in the above mentioned Civil Writ petition No. 13913 of 2008 in view of the subsequent events that have taken place.

#### Respectfully Showeth:

1. That the above mentioned writ petition was filed by the applicant / petitioner in public interest before this Hon'ble court on 6th August, 2008, praying therein that a writ of mandamus directing the official respondents i.e. respondent No.1 and 2 be issued not to distribute the awards to the non official respondents i.e. respondents No. 3 to 10, as they were the members of the Advisory Board, constituted by the State of Punjab for the purpose of final distribution of awards on the basis of a short list prepared by the Screening committee, so constituted by the State. All these non official respondents were the members of the Advisory Board, the final authority to determine



the name of the awardees in various categories and respondent No. 4, was as well a member of the Screening Committee. Therefore, in view of such an impropriety illegality and abhorrence to the common sense of justice, a prayer was made to direct the official respondents not to distribute the awards in the function which was going to be held on 8<sup>th</sup> August, 2008.

- 2. That the above said writ petition came for hearing before the Division Bench consisting of Hon'ble Mr. Justice J.S. Khehar, the then Acting Chief Justice, and Hon'ble Mr. Justice A.K. Mittal on 7<sup>th</sup> August, 2008. The Hon'ble Division Bench issued notice of motion for 16.9.2008 and regarding the stay, it was observed by the Hon'ble Bench that the good sense would prevail and the awardee respondents would not go to receive the award if the facts mentioned in the writ petition are correct. And if they receive the award inspite of this notice, then they would be directed to return the same.
- 3. That the news item regarding the notice of motion and observations of the Hon'ble Division Bench were widely published in regional as well as National daily papers on 8<sup>th</sup> August, 2008, those are annexed herewith as **Annexure P-6**, **P-7 and P-8**.
- 4. That unfortunately, inspite of all this, the function was held on 8<sup>th</sup> August, 2008 and except respondent No.8, all the non official respondents went there to receive the award and they received it. The respondent No. 2 and 3 told lies to the Press as well as to the television, reporters in order to justify their illegal, unconstitutional and morally improper conduct. This fact has necessitated the amendment of the present writ petition.

- 5. That petitioner pray the kind indulgence of this Hon'ble Court for making the following amendments by way of adding the following paras after para No. 8 of the writ petition:
- That inspite of the unsavory controversy as published in the 8-A. newspapers, the function was held on 8th August, 2008 in the Law Auditorium of Panjab University, Chandigarh at about 4.00 PM. All the non official respondents except one i.e. Respondent No. 8 i.e. Sh. J.S. Sidhu Damdini, editor, Punjabi Tribune, declined to receive the award after hearing the voice of his conscience. The news item regarding the function was published in the Hindustan Times on 9th August, 2008, the copy of which is attached herewith as Annexure P-9. The reading of the news items and what respondent No. 2 and Respondent No. 3 said on the PTC Channel justifying the awards to the non official respondents was really very unfortunate and blatant attempt to suppress the truth. The conduct of the respondents in this case is almost borders on the 'moral turpitude' as laid down by the Allahabad High Court in a judgment reported in AIR 1959 Allahabad, 173 and later on approved by the Hon'ble Supreme Court in a case reported in 1997 (4) SCC, page 1, which reads as under:

"The expression 'moral turpitude' is not defined anywhere. But it means anything done contrary to justice, honesty, modesty or good morals. It implies depravity and wickedness of character or disposition of the person charged with the particular conduct. Every false statement made by a person may not be moral turpitude, but it would be so if it discloses vileness or depravity in the doing of any private and social duty which a person owes to his fellowmen or to the society in general. If therefore the individual charged

with a certain conduct owes a duty, either to another individual or to the society in general, to act in a specific manner or not to so act and he still acts contrary to it and does so knowingly, his conduct must be held to be due to vileness and depravity. It will be contrary to accepted customary rule and duty between man and man."

Good literature is the channel between spiritual vision and human being and the men of literature try to show such type of vision to the normal human beings. Solzhenitsyn, a great Russian Novelist, who died a few days ago, wrote that while an ordinary man was obliged "not to participate in lies' artists had greater responsibilities. 'It is within the powers of artist to do much more to defeat the lie'. Unfortunately, the unofficial respondents who are all men of literature, journalism and art have told lies and supported on the television which has dismayed many of their admirers, generating a long term effect on the moral of the people and cynicism among them.

- 8-B. That the conduct of the respondents is illegal, improper, unfair, dishonest, and unconstitutional, and also against morality as set out in Article 19 Clause 2 and 4 of the Constitution of India, which reads as under:
  - (2) Nothing in sub-clause (a) of clause (1) shall affect the operation of any existing law, or prevent the State from making any law, in so far as such law imposes reasonable restrictions on the exercise of the right conferred by the said sub-clause in the interests of the sovereignty and integrity of India, the security of the State, friendly relations with foreign States, public order, decency or morality or in relation to contempt of court, defamation or incitement to an offence.

(4) Nothing in sub-clause (c) of the said clause shall affect the operation of any existing law in so far as it imposes, or prevent the State from making any law imposing, in the interests of the sovereignty and integrity of India or public order or morality, reasonable restrictions on the exercise of the right conferred by the said sub-clause.

By morality here in this Article is meant the ideas about right and wrong which are accepted by the right thinking members of the society as a whole of the country. Morality is a fluid concept and its content will depend upon the time, place and stage of civilization. Looking at the facts of the present writ petition and the conduct of the respondents, it certainly comes out that their conduct is opposed to the provisions of the Constitution. Therefore, the purpose of giving award to these men of literature, journalism and art would get defeated because the most powerful effect of literature on the people is a moral effect. And it is this effect if rightly appreciated gives literature its unique value. The refusal of respondent No. 8 not to receive the award on the question of his conscience is a pointer to the fact how the other genuine awardees would be feeling distressed because of the illegal and inappropriate conduct of respondents. The questionable conduct of the non official respondents has ultimately tainted the whole process of award giving, which defeated the purpose of the awards itself.

8-C. That it is a well established principle and there is a long line of cases showing that it is not merely of some importance what is the fundamental importance that justice should not only be done, what should manifestly and undoubtedly be seem to be done. Nothing is to be done which creates even a suspicion that there has been an

improper interference with the course of justice. However, the present case, when the 7 non official respondents received the award even when they were members of the Advisory Board and had an important role when the final list of the awardees was being prepared. The contention of the respondent No. 3 on the PTC Channel that they had gone out when their names were being considered for award, is immaterial in view of the law laid down in Kripak's case as mentioned above. The whole process of these award giving was tainted and vitiated and liable to be set aside on this ground alone.

- Auditorium of Law Department, a souvenir was distributed and as per that souvenir, apart from these eight non official respondents, the award was given to other 20 persons. The petitioner has no grouse against those writers and artists, therefore, they are not being impleaded as a party in this amended writ petition and the petitioner is confining his relief to the 10 respondents and they should be directed to return the award because these eight non official respondents have done great injustice in selecting themselves as awardees and it is well known that injustice anywhere threatens justice everywhere.
- 8-E. That the list of the 28 writers was issued in the Souvenir issued by the Director, Language Department, Punjab on 8<sup>th</sup> August, 2008 and there were 14 writers for each of the year i.e.2007 and 2008 and out of these 28, eight non official respondents were from the members of the Advisory Board constituted by the Department and some of them were members of the Screening Committee also. That apart from these eight non official respondents, awards were

given to 28 persons as is evident from **Annexure P-10**. However, apart from the eight non official respondents, the petitioner has nothing to say about other awardees. The petitioner is confining the relief in this writ petition to the non official respondents alone.

## In para 9(1), the last part of the para 9(1) (a) is to be read as:

"The writ of mandamus deserve to be issued on the ground that the awards given to the non-official respondents are illegal, unconstitutional, bordering on the definition of moral turpitude as approved by the Hon'ble Supreme Court in the case of Allahabad Bank and Another vs. Deepak Kumar Bhola reported in 1997 (4) SCC page 1. Therefore, in view of these facts, the non official respondents be directed to return the award return the award at the earliest in the interest of justice and fair-play.

## Para No. 9(1) (b) is to be read as under:

That the conduct of the official respondents is also illegal, and against the service conduct rules, unconstitutional, against the public policy and also against the basic principles of natural justice as the unofficial respondents were made member of the Advisory Board though their names were short listed by the Screening Committee for the purpose of giving the awards. Respondent No. 4 was a member of the Screening Committee, Advisory Board and finally received the award of Five Lakhs Rupees. Therefore, in view of such facts and circumstances of the present case, the official respondents should also be directed to proceed according to law to get back the award money which has been illegally given to the non official respondents, damaging the very purpose of giving such awards.

Civil Writ Petition under section 226 / 227 of the Constitution of India for the issuance of writ of

mandamus to the official respondents to initiate legal proceedings against the nonofficial respondents to return the award.

With the further prayer that direction be issued to the non official respondents to return the award at the earliest, as the same is illegal, unconstitutional against the principles of natural justice and also against the public policy regarding decency and morality as enshrined in Article 19 (2) and (4) of the Constitution of India in the interest of justice and fair play.

#### Respectfully Showeth:

- 1. That the petitioner is a citizen of India and the cause of action has also arisen within the jurisdiction of this Hon'ble Court, therefore, the petitioner is competent to invoke extraordinary jurisdiction under Articles 226 / 227 of the Constitution of India in public interest, as the petitioner is deeply connected with the field of Art and Literature.
- 2. That the petitioner is a writer in English, Hindi and Punjabi, associated with the Literary World for the last about three decades. And presently, the petitioner is Director, Update Video Publications and consultant Media Video Limited. The petitioner has published his books of English Poetry namely "Visions" in 1986 and thereafter "Nature's Nodes" in 1989. The articles of the petitioner have been published in various newspapers and journals. Therefore, as a man of literature, the petitioner is deeply interested in the development of literature and art and especially the value system which the

writers must uphold to be a role model in the society. So what has published in the newspapers regarding the award distribution and the greed of the writers by selecting themselves for the award has really distressed the petitioner. And finding no other option, the petitioner is filing this petition so that a larger public interest be served.

- 3. That like earlier years, the Language Department of the Punjab Government also planned to distribute awards to the distinguished writers in Punjabi, Hindi, journalists and various other persons involved in the field Art and Literature. For this purpose, the Punjab Government constituted that Advisory Board, Language Department Punjab, 2008 consisting of 32 persons, the list of which is annexed here as Annexure P-1. And thereafter the Punjab Government constituted the Screening Committee of six persons, the names of those persons are mentioned in Annexure P-2.
- That after constituting the Advisory Board and the Screening Committee, the meeting was held on 21<sup>st</sup> July, 2008, for the purpose of short-listing the names of the Writers, Artists to whom the award was given for the year 2007-2008. Out of the total list of 234 writers of various languages, journalists and others, the Screening Committee selected 78 writers, the name of which are mentioned in Annexure P-3. In each of the 13 category which are mentioned in this Annexure, the Screening Committee selected six persons out of which the selection was to be made by the Advisory Board.
- 5. That the controversy as involved in the present writ petition has arisen because so many improprieties have been committed while finalizing the list of the awardees by the Advisory Board.

.

Unfortunately, all the awardees i.e. non official respondents were the members of the Advisory Board. And some of them were the members of the Screening Committee as well. For instance, Dr. Dalip Kaur Tiwana i.e. Respondent No. 4, was a member of the Advisory Board, then member of the Screening Committee and lastly one of the awardees for rupees five lakh for Punjabi Sahit Shiromani Puraskar for the year 2007. Incidentally, all the non official respondents who have been given awards were the members of the Advisory Board. This action of non-official respondents is basically against the basic principle of justice and fairness that nobody can be judge in his own case. However, this is what has happened in the present case and these respondents have unfortunately 'glorified' themselves with the award. Earlier, to the present award giving process, if any member's name was to be considered for the award, then that member used to resign from the Advisory Board. However, this time, all these well tested traditions were thrown to the winds and the non official respondents in a very indignified manner became part of the selection process of these awards and ultimately got themselves selected for the awards

6. That respondent No. 3 and 4 have been selected for the award of Punjabi Sahit Shiromani Puraskar for the year 2008 and 2007 respectively, the prize money for which was increased from 2.5 lakhs to 5.0 lakhs. Similarly, Dr. Dhanwant Kaur was a member of the Advisory Board, whose husband Dr. Jaswinder Singh i.e. respondent No. 9 has been selected for the award of Shiromani Punjabi Lekhak / Punjab Aalochak. The other serious impropriety, which has been committed is: that Sh. Chhotu Ram Maudgil, who retired as a Assistant Director from the Language Department, Punjab and presently is Director of Haryana Punjabi Sahityak

Academy, Panchkula has also been wrongly and illegally selected for the award of Shiromani Punjabi Sahityakar as a candidate from outside Punjab. In fact, he belongs to Punjab and throughout served in the Language Department of Punjab, therefore, he was not eligible to be considered under the category of this Shiromani Punjabi Sahityakar as from outside Punjab. Similarly, the other non official respondents were members of the Advisory Board, 2008 and were selected for different awards by the same Advisory Board of which they were the members. The Hon'ble Supreme Court in the case of A.K. Kripak vs. Union of India AIR 1970 SC Page 150, clearly laid down that if a member of the Selection Board was himself a candidate and ultimately was selected for the post, was clearly against the principles of natural justice. The Hon'ble Supreme Court in that celebrated case, set aside the selection simply on the ground that the selected candidate was a member of the Selection Board, even though he did not attend the meeting of the selection board when his own name was being considered. However, in the present case, right from the membership of the Advisory Board, the Screening Committee and ultimately the selection of awards, these non official respondents to whom the awards has been given, attended all the proceedings which were necessary for the selection of the awardees.

7. That the present case is serious and would have grave repercussions because it relates to the men of Literature and Art, who are supposed to uphold higher values of probity and morality in the society in which they live. And if such people start stooping low, because of their personal greed, then the serious moral crisis are bound to arise in that society. And if the newsitems, which have been published regarding the whole affair of these award giving to

the writers are read, which are annexed herewith as **Annexure P-4** and P-5, then the effect of such impropriety of the respondents becomes clear. A writer or an Artist is supposed to defend humanity, dignity, integrity, morality, goodness and the superior mental spiritual nature of man and not to degrade the same by his own low conduct. In the present case all the awardees of the prize, given by the State of Punjab, have not behaved in the manner, in which a writer or an artist is supposed to behave. Their conduct is both against the moral values and the principles of natural justice, which is abhorrent to our concept of justice.

- 8. That earlier these awards used to be given in the month of November in the Language Bhawan, Patiala and the occasion was to be celebrated for more than a week and the distinguished writers and artists used to attend the same, but this year for the reasons best known to the authorities, the award giving ceremony is being held on 8<sup>th</sup> August, 2008 at Chandigarh. This is very surprising for all the writers and the intellectuals because the Government is acting in a great hurry.
- 8-A. That inspite of the unsavory controversy as published in the newspapers, the function was held on 8<sup>th</sup> August, 2008 in the Law Auditorium of Panjab University, Chandigarh at about 4.00 PM. All the non official respondents except one i.e. Respondent No. 8 i.e. Sh. J.S. Sidhu Damdini, editor, Punjabi Tribune, declined to receive the award after hearing the voice of his conscience. The news item regarding the function was published in the Hindustan Times on 9<sup>th</sup> August, 2008, the copy of which is attached herewith as Annexure P-9. The reading of the news items and what respondent No. 2 and Respondent No. 3 said on the PTC Channel

justifying the awards to the non official respondents was really very unfortunate and blatant attempt to suppress the truth. The conduct of the respondents in this case is almost borders on the 'moral turpitude' as laid down by the Allahabad High Court in a judgment reported in AIR 1959 Allahabad, 173 and later on approved by the Hon'ble Supreme Court in a case reported in 1997 (4) SCC, page 1, which reads as under:

"The expression 'moral turpitude' is not defined anywhere. But it means anything done contrary to justice, honesty, modesty or good morals. It implies depravity and wickedness of character or disposition of the person charged with the particular conduct. Every false statement made by a person may not be moral turpitude, buti t would be so if it discloses vileness or depravity in the doing of any private and social duty which a person owes to his fellowmen or to the society in general. If therefore the individual charged with a certain conduct owes a duty, either to another individual or to the society in general, to act in a specific manner or not to so act and he still acts contrary to it and does so knowingly, his conduct must be held to be due to vileness and depravity. It will be contrary to accepted customary rule and duty between man and man."

Good literature is the channel between spiritual vision and human being and the men of literature try to show such type of vision to the normal human beings. Solzhenitsyn, a great Russian Novelist, who died a few days ago, wrote that while an ordinary man was obliged "not to participate in lies' artists had greater responsibilities. 'It is within the powers of artist to do much more to defeat the lie'. Unfortunately, the unofficial respondents who are all men of

literature, journalism and art have told lies and supported on the television which has dismayed many of their admirers, generating a long term effect on the moral of the people and cynicism among them.

- 8-B. That the conduct of the respondents is illegal, improper, unfair, dishonest, and unconstitutional, and also against morality as set out in Article 19 Clause 2 and 4 of the Constitution of India, which reads as under:
  - (2) Nothing in sub-clause (a) of clause (1) shall affect the operation of any existing law, or prevent the State from making any law, in so far as such law imposes reasonable restrictions on the exercise of the right conferred by the said sub-clause in the interests of the sovereignty and integrity of India, the security of the State, friendly relations with foreign States, public order, decency or morality or in relation to contempt of court, defamation or incitement to an offence.
  - (4) Nothing in sub-clause (c) of the said clause shall affect the operation of any existing law in so far as it imposes, or prevent the State from making any law imposing, in the interests of the sovereignty and integrity of India or public order or morality, reasonable restrictions on the exercise of the right conferred by the said sub-clause.

By morality here in this Article is meant the ideas about right and wrong which are accepted by the right thinking members of the society as a whole of the country. Morality is a fluid concept and its content will depend upon the time, place and stage of civilization. Looking at the facts of the present writ petition and the conduct of the respondents, it certainly comes out that their conduct is

opposed to the provisions of the Constitution. Therefore, the purpose of giving award to these men of literature, journalism and art would get defeated because the most powerful effect of literature on the people is a moral effect. And it is this effect if rightly appreciated gives literature its unique value. The refusal of respondent No. 8 not to receive the award on the question of his conscience is a pointer to the fact how the other genuine awardees would be feeling distressed because of the illegal and inappropriate conduct of respondents. The questionable conduct of the non official respondents has ultimately tainted the whole process of award giving, which defeated the purpose of the awards itself.

- That it is a well established principle and there is a long line of 8-C. cases showing that it is not merely of some importance what is the fundamental importance that justice should not only be done, what should manifestly and undoubtedly be seem to be done. Nothing is to be done which creates even a suspicion that there has been an improper interference with the course of justice. However, the present case, when the 7 non official respondents received the award even when they were members of the Advisory Board and had an important role when the final list of the awardees was being prepared. The contention of the respondent No. 3 on the PTC Channel that they had gone out when their names were being considered for award, is immaterial in view of the law laid down in Kripak's case as mentioned above. The whole process of these award giving was tainted and vitiated and liable to be set aside on this ground alone.
- 8-D That at the time of the function on 8<sup>th</sup> August, 2008 held in the Auditorium of Law Department, a souvenir was distributed and as

per that souvenir, apart from these eight non official respondents, the award was given to other 20 persons. The petitioner has no grouse against those writers and artists, therefore, they are not being impleaded as a party in this amended writ petition and the petitioner is confining his relief to the 10 respondents and they should be directed to return the award because these eight non-official respondents have done great injustice in selecting themselves as awardees and it is well known that injustice anywhere threatens justice everywhere.

8-E. That the list of the 28 writers was issued in the Souvenir issued by the Director, Language Department, Punjab on 8<sup>th</sup> August, 2008 and there were 14 writers for each of the year i.e.2007 and 2008 and out of these 28, eight non official respondents were from the members of the Advisory Board constituted by the Department and some of them were members of the Screening Committee also. That apart from these eight non official respondents, awards were given to 28 persons as is evident from Annexure P-10. However, apart from the eight non-official respondents, the petitioner has nothing to say about other awardees. The petitioner is confining the relief in this writ petition to the non-official respondents alone.

- 9. That the writ of mandamus deserve to be issued on the following grounds:
  - The writ of mandamus deserve to be issued on the ground that the awards given to the non-official respondents are illegal, unconstitutional, bordering on the definition of moral turpitude as approved by the Hon'ble Supreme Court in the case of Allahabad Bank and Another vs. Deepak Kumar Bhola reported in 1997 (4) SCC page 1. Therefore, in view of these facts, the non official respondents be directed to return the award return the award at the earliest in the interest of justice and fair-play.
  - II. That the conduct of the official respondents is also illegal, and against the service conduct rules, unconstitutional, against the public policy and also against the basic principles of natural justice as the unofficial respondents were made member of the Advisory Board though their names were short listed by the Screening Committee for the purpose of giving the awards. Respondent No. 4 was a member of the Screening Committee, Advisory Board and finally received the award of Five Lakhs Rupees. Therefore, in view of such facts and circumstances of the present case, the official respondents should also be directed to proceed according to law to get back the award money which has been illegally given to the non official respondents, damaging the very purpose of giving such awards.

- That the conduct of the official respondents is also illegal and against the basic principles of natural justice, allowing the unofficial respondents to be part of the Advisory Board, which was to select the name of the awardees. The writ of mandamus stopping them to proceed with the illegal activity of giving the award deserve to be issued.
- 10. That the main law points which arises in this writ petition are as under:
  - i) Whether the conduct of the unofficial respondents being a judge in their own case is against the established principle of law of the Hon'ble Supreme Court or not?
  - ii) Whether the conduct of the official respondents is illegal and against the principles of natural or not?
  - iii) Whether the conduct of the respondent is unconstitutional, against public policy and morality, as mentioned in Article 19 (2) and (4) or not?
- 11. That the petitioner have no other remedy except approaching this Hon'ble Court through the present writ petition, as all other remedies are to be ineffective.
- 12. That the petitioner had filed no other petition or revision in this Hon'ble Court or in the Hon'ble Supreme Court of India for seeking

the same relief, except CWP No. 13913 of 2008, which is being amended through this writ petition. No Caveat has been filed.

It is therefore respectfully prayed that after summoning and perusing the record of the petitioner's case –

- i. Writ of mandamus be issued to non official respondents to return the award as they have got the same being a judge which is abhorrent to the common sense of justice.
- ii. Any other writ, order, direction be issued as this Hon'ble Court may deem fit in the peculiar facts and circumstances of the present case.
- iii) issuance of advance notices to the respondents may kindly be dispensed with;
- iv) filing of certified copies of Annexures may kindly be dispensed with;
- v) cost of petition may kindly be awarded in favour of the petitioner and against the respondents.





# 'Self-selection' in literary awards

Notice to govt, board members

HT Correspondent Chandigarh, August 7-

THE CONTROVERSY over eight members of the Screening Committee and the Advisory Board, set up by Punjab to shortlist people for annual literary awards, selecting themselves for prestigious awards has reached the Punjab and Haryana High Court, which today issued notice to the state government.

The awards, including the Punjabi Sahit Shiromani Puruskar, are scheduled to be presented at a ceremony on the Panjab University campus in Chandigarh on Friday.

Petitioner Pradeep Joshi has argued through his counsel that it was a "classic case of moral sickness" that all respondents, who were members of the Advisory Board and Screening Committee set up to se-

lect the most deserving for various awards for 2007 and 2008 — and had been selected themselves — had committed improprieties while finalising the list.

Among those listed as respondents in the PIL are the Punjab government; Education Minister Dr Upinderjit Kaur, and non-official respondents ("who selected themselves") Jaswant Singh Kanwal; Dr Dalip Kaur Tiwana; Dr Karnail Singh Thind; Jhotu Ram Maudgil, Director, Haryana Academy, Panchkula; Dr Ravinder Kaur, Head of the Sanskrit Department of Panjab University; G.S. Sidhu, editor of Chandigarh-based Punjabi daily; Dr Jaswinder Singh; and Dr Chander Thrikha.

Some of these eight awardees were

members of both the Screening Committee as well as the Advisory, Board. "Therefore, the process of selection of the names of the awardees is vitiated. All these awardees of various prizes were judges, in their own cases, and their action is against the basic principles of natural justice and fairness."

He added that earlier, if any member were to be considered for an award, the member concerned would

resign from the panel. However, this time all such norms had been thrown to the winds, he added.

On July 21, the Punjab Language Department had constituted a screening committee of six persons for shortlisting the names, to be subsequently considered for the awards by the 32-member Advisory Board set up in February. The selections were made on July 26.

The petitioner pointed out that noted writer Jaswant Singh Kanwal and Dr Dalip Kaur Tiwana, who were on the board, had been selected for the Punjabi Sahit Shiromani Puraskar for 2008 and 2007, respectively, the prize money for which had been increased from Rs 2.5 lakh to 5 lakh.

Similarly, Dr Dhanwant Kaur was also a member of the Advisory Board, which had selected her husband Dr Jaswinder Singh (among the respondents) for an award.

The Division Bench of acting Chief Justice J.S. Khehar and Justice Ajay Kumar Mittal issued notices for September 17 to the Punjab government, Education Minister Dr Upinderjit Kaur and all the private respondents.

## HC issues notice of motion to awardees

Just over 24 hours before the presentation of awards for excellence in literature and journalism by the Punjab Government, the Punjab and Haryana High Court today issued notice of motion for September 17 to the state and other respondents.

The awards are to be presented during a function scheduled to be held at the Panjab University Law Auditorium. Challenging the awards, Panchkula-based petitioner Pradeep Joshi alleged the selectors had chosen themselves for the awards.

Citing instances from the past, he contended, earlier a member would resign from the advisory board, if his name was to be considered for the award.

However, the time-tested traditions were this time thrown to the winds, and the non-official respondents, in an undignified manner, became part of the selection process and ultimately got themselves selected for the awards, the petitioner argued in the petition filed in public interest.

Quoting examples, the petitioner asserted noted writer Jaswant Singh


Kanwal and Dr Dalip Kaur Tiwann were selected for "Punjabi Sahit Shiromani Puraskar", the prize money for which had been doubled from Rs.2.5 lakh.

The petitioner's counsel referred to Supreme Court ruling in A.K. Kripak versus Union of India, 1970, matter where the court had laid down that the selection of a candidate, who was a member of the selection board, was clearly against the principles of natural justice.

The apex court, in the case, had set aside the selection as the selected candidate happened to be a member of the selection board.





- 1. That the Punjab Government has notified Government instruction No. 6/199/92-1 Edu. cell/26245 dated 5.11.2002 for constituting 'State Advisory Board' for giving advice in the different fields of the Language Department.

- (f) to provide its suggestions and solid proposals for the overall working of Language Department. (copy annexed as R-1) As per these instructions the Government of Punjab had constituted State Advisory Board and had nominated Official and non-official members vide their Notification No. 6/199/92- 1 Edu.cell/4294 dated 18.2.2008 and No. 6/199/92- 1 Edu.cell/4290 dated 18.2.2008 respectively (copy annexed as R-2 & R-3). These members are from different fields e.g. Punjabi literature and language, Hindi literature, Sanskrit literature, Urdu literature, Media and Journalism.
- 2. That the Government of Punjab further constituted the 'Screening Committee' to summarize the panels of writers for awards mentioned in Agenda items vide notification no. 6/199/92- 1 Edu.cell/4298 dated 18.2.2008 (annexed as R-4).
  - That after constituting State Advisory Board and Screening Committee of the Language Department prepared Agenda for the members of the State Advisory Board for consideration of different categories of Awards for the Year 2007 and 2008. State Advisory Board meeting was fixed on 23.7.2008 and the agenda was circulated. The 'Screening Committee' constituted by the Government considered the panel of writers in agenda items for State Advisory Board and submitted its recommendations in sealed cover for the consideration of State Advisory Board. Out of total 280 names of writers/artists, 'Screening Committee' short listed the panel of 89 writers/artists. On 23.7.2008 the meeting of State Advisory Board was held under the Chairmanship of Dr. Upinderjit Kaur, Hon'ble Education & Languages Minister, Punjab. At the outset of the meeting it was clarified that the State Advisory Board is empowered to take decision regarding the

finalization of the 14 categories of awards. It was indicated to all the

members of the Board that the suggestions of the 'Screening Committee' are not final

final. However Board can decide the names of any writer mentioned in the panel of agenda and can also recommend the names of other deserving writers not mentioned in the Panel of Agenda. It was discussed that in the past many eminent writers/artists could not be considered for awards as the State Advisory Board at that time had decided that if the member is to be considered for award, he/she had to resign. This had resulted in either not considering the eminent people for awards despite their commendable work or to keep State Advisory Board devoid of the advice of eminent writers. It is also stated that as per para 7 of R-1 the State Advisory Board is authorized to decide its own procedure. The State Advisory Board accordingly considered the issue at length. After consideration and threadbare discussion it was decided that it will not be appropriate to deny awards to eminent writers/artists only because of the factum that they happen to be members of the Board. It was also noticed that in many other organizations also the practice is that if a person's name is considered by a Board and such person happens to be member of he Board, he abstains from participating in the proceedings by withdrawing from the meeting while his case is being considered. The Board therefore, decided that a similar procedure may be adopted and the: members who have sent their resignation because of the fact that there names were under consideration for awards, their resignations be rejected and they be requested to join in the: meeting. The members whose names were included in different panels of the agenda therefore

abstained from the meeting when his/her name was considered during

discussions. The extract from the proceedings is annexed as R-5: The similar procedure was adopted in the 'Screening Committee' where Dr. Dalip Kaur Tiwana had abstained from Screening Committee meeting when her name was considered on 21.7.2008.

- 4. That in the meeting of State Advisory Board, 8 members of the State Advisory Board were selected for awards for their contribution in different categories. It is submitted that all the selected awardees are prominent literary figures in their respective fields. Some of them are of International fame. Their Biodatas are annexed at Annexure R-6, who were members of the State Advisory Board. It is further submitted that there were some other writers/artists whose names were included in the agenda, for example Dr. Satinder Singh and Bhai Nirmal Singh Khalsa, but were finally not selected for awards by the Board.
- Board some other artists were selected for the awards, whose names were neither mentioned in the panel of Agenda nor were they members of the Board. Bhai Banta Singh Ragi, Bhai Gurcharan Singh were given awards for the Shiromani Ragi category for the 2007 and 2008. Likewise S. Gurbachan Singh Sachdev was given award for Shiromani Sangeetkar category. These awardees were prominent in their particular field. S. Jaswant Singh Kanwal & Dr. Dalip Kaur Tiwana are not famous at National level only but they are the personalities of International fame for their contribution to the Punjabi
  - That accordingly the awardees were selected with collective decision of the State Advisory Board on 23.7.2008. These awards were bestowed on the awardees at a State level function held at Law Auditorium, Panjab University, Chandigarh on 8.08.2008.



- 1. That in reply to para 1 of the petition, it is submitted that the instant writ petition is not maintainable in its present form as no cause of action has arisen for the petitioner to file the writ petition.
- 2. That the claim of the petitioner that he is writer in English, Hindi and

  Punjabi is denied for want of knowledge. However it is wrong to suggest
  that the writers have selected themselves for the awards.
- 3. That the contents of the para are admitted to the extent that the Punjab Government constituted State Advisory Board to recommend the names of suitable persons for various Awards. However, it is denied that any member has recommended himself for the Award. The position has been explained in the Preliminary Submissions above.
- 4. That the contents of para 4 of the petition are admitted to the extent that the meeting was held on 21.7.2008. Annexure P- 3 is a matter of record.
- 5. That para No.5 is denied. The factual position has been explained in preliminary submissions from para 1 to 6.

That para No.6 is admitted to the extent that the amount of award was increased from Rs. 2.5 lac to 5.00 lac and from 1.00 lac to 2.50 lac. Rest of the Para denied as the awardees were selected by the State Advisory Board. It is submitted that S. Jaswant Singh Kanwal and Dr. Dalip Kaur Tiwana are the international personalities. They have got National/International awards

Academy Award, Sarswati Award and Padamsri Award. Moreover the State

from many reputed institutions. Even Dr. Dalip Kaur Tiwana has got Sahit

Advisory Board while considering the name of the awardees considered their overall contribution to Literature and other fields. It is further clarified that although Shri Chottu Ram Moudgil had served with the Punjab Government. But he is now residing in Haryana from the last ten years and he had fulfilled the required qualifications for award outside from Punjab. As per the decision of State Advisory Board, the members remained absent from meeting while his/her category was decided. So the member was not the part of selection committee (State Advisory Board) when his/her name was considered for award. Thus, it is not a case of being the judge in his own cause. Hence, the contention of the petitioner is denied.

- 7. That para No.7 is denied in view of the submissions made in para-5 of the written statement.
- 8. That para No.8 is denied as there is no rule to distribute the awards in the month of November. There are so many occasions when the awards were given on different months as the awards for the year 2001, 2002, 2003 & 2004 were distributed on 3rd December, 2004 and awards for the year, 2005 was distributed on 5.12.2005. The awards distributed on 8.8.2008 included awards for the year 2007 and 2008 and thus were distributed with 5 considerable delay rather than in a hurry as alleged by the petitioner.
- 8 (a) That Para No. 8 (a) of the petitioner is admitted to the extent that the function was held on 8th August, 2008 in the Law Auditorium of Panjab University Chandigarh and Sh. J.S. Damdami had declined to receive the award. Rest of the Para is wrong hence denied. The factual position has already been explained in the foregoing paras.

- 8 (b) That the Para 8 (b) is denied. The factual position has already been explained in the foregoing paras.



# 2. The Constitution of the State Advisory Board:

The board will be constituted as under:-

#### (A) Ex-officio members:-

(i) The minister of Languages



- (iii) Principal Secretary/ Secretary Cultural Affairs. (Member)
- (iv) Principal Secretaryof Finance Department or its representative not less than the rank of Additional Secretary. (Member)
- (v) Vice Chancellors from the Punjab State Universities having the background of Culture and Language or their representatives not less than the rank of Dean. (Member)
- (vi) The president or the General Secretary of the following institutions:- Punjabi Kala Parishad, Chandigarh, Punjabi Academy, I,udhiana, Punjabi Academy, Delhi, Punjabi Sahit Academy, Haryana, Punjabi Sahit Sabha, New Delhi, Kendri Punjabi Sabha (Regd.), Kendri Punjabi Lekhak Sabha (Sekhon) (Member)
- (vii) Two members of Kendri Sahit Academy and Sangeet Natak Academy, New Delhi. (Member)
- (viii) Director, Language Department, Punjab (Member Secretary)

# (B) Non-Official Members:-

The non-official members of the board would be nominated by the Chief Minister on the recommendations of the Language Department as under:-

- 1. 12 members related with the different forms of Punjabi Literature and Culture as Lok Gaiki, Kirtan, Dhadi and Bhet-Gaiki.
- 9 members related with the different forms of Literature and Language of Hindi, Urdu and Sanskrit. Each Language will contain three members.
  - 3 members from the prominent personalities with the newspapersl television and media.



4. 6 members from the prominent person~lities national fame related with the fields of Arts, Science, Social Service, Medicine, Engineering, Environment etc.

#### It is made clear that:-

- (a) The members to be nominated under section 2(A) 1, at least four members would be related with Punjabi Literature and Language.
- (b) The members to be nominated under section 2(A)(I)and (2) generally should be the awardees of Kendri Academies or State Academies or other organizations of national level/ writers/ Gaik (singers)

#### 3. The tenure of the members:

- (A) The Ex-officio nominated members would till their services remain the members of the Board from section 2(A) to (9) under section 2(A) (1) to (4) the tenure of the non-official would be three years from the date of notification.
- (B) But this is also made clear that the name~ of 1/3 members among the nonofficial members of the first time constituted Board would be taken through
  draw ad the names drawn in the first draw would be members for on~ year.

  The names in the second draw would be members for two years arid the
  remaining members would be members for complete three years. After this,
  every year from section 2(A) to (4) among the nominated members 1/3
  members would not remain the members after 3 years, and new members

#### 4. Resignation/Removal of the Non-official members:

- (a) Any Non-official member during his tenure can submit his written resignation to the President or member Secretary. Such resignation would be taken applicable immediately from the date of the resignation given.
- (b) If any member remains in Police or Judicial custody for 48 hours or more or a case of immorality is registered or he is liable to propagate in favor of or against any particular person or persons then the President of the Board would suspend him immediately and he can start the proceedings of his termination.
- (c) New person would be nominated on the vacant post due to resignation, death or removal. Such nominated member would be the board member till the remaining time of the vacant post.

#### 5. Head Office:

The head office of the State Advisory Board will be the Language Department,
Punjab, Patiala.

#### 6. Meeting and Coram:

- (a) There will be at least two meetings in a year of the State Advisory Board and the interval between these two meetings will not be more than 180 days.
- (b) The Coram for the working of the State Advisory Board would be at least the fifth part of the total members or at least 8 members which so ever is more. Provided amont the ex-officio members Principal Secretary, Higher

Education and Language and Director, Language Deptt. presence would be compulsory.

7. The procedure regarding working: The board president in its first meeting of the board by preparing the detailed procedure as per the recommendations of the Member Secretary, Principal Secretary, Higher Education and Language, would implement it after seeking Board's approval.

# 8. Honorarium & T.A./D.A.

- (a) Ex-officio members would be entitled to have their T.A./D.A. from their respective Department.
- (b) Non-official nominated members would get 500/- rupees as honorarium per meeting and T.A. equal to group 'A' Officers.
- 9. This Board is constituted with the approval of A.V. letter No. 1/35/ 200- 3N
- .K. 2/29J 5, dated 8th November, 2002 of the Finance Department.





## RESPECTFULLY SHOWETH:

# PRELIMINARY OBJECTIONS/SUBMISSIONS:

1. That the petitioner has not approached this Hon'ble Court with clean hands and has concealed the material facts. The petitioner has time and again averred in the writ petition and moreso, the gist/basis of the present writ petition is that "the process of selection of the names of the award is vitiated that all these eight awardees of the various prizes were judges in their own case and their action is against the basic principles of

natural justice and fairness". The above referred averments are factually incorrect, misconceived and against the record, qua the answering respondent. It is pertinent to mention here that the answering respondent though initially was a member of the advisory board, however, he has submitted his resignation well in advance from the effective date of start of the entire process to finalise the names of the awardees. To substantiate these averment a true translation of the letter dated 17.7.2008 addressed to the Director, Language Department-Punjab and a true translated copy of news item dated 21st of July, 2008 is annexed herewith as is annexed herewith as Annexure R-10/1 and R-10/2.

- 2. That it is humbly submitted that it is the well settled preposition of law in various judicial pronouncements by the Hon'ble Supreme Court of India as well as by this Hon'ble Court that-
  - Concealment of facts-such petitioner is not entitled to any discretionary relief and his petition is liable to be dismissed with costsmisleading averments made in the writ petition, this is an attempt to mislead the

That on the one hand the petitioner has impleaded the answering respondent in the present writ petition, however, the entire perusal of the writ petition reveals not even a single averment impugning any action on the part of the answering respondent. ### RESPECTFULLY SHOWETH:

### PRELIMINARY SUBMISSIONS:

1. That the present writ petition has been filed by the petitioner in Public Interest whereas the petitioner is trying to redress his personal grievance of not having been nominated or selected for the awards that he has impugned. The writ petition does not stem from any larger public interest as the answering respondents are persons of eminence in their respective fields of Literature, Art and Culture. The awards being the Punjabi Culture Shiromani Prize, Shiromani Panjabi Writer, Shiromani Hindi Writer, Shiromani Urdu Writer, Shiromani Sanskrit Writer, Shiromani Panjabi Poet, Shiromani Panjab Writer/Punjabi Critic, Shiromani Panjabi Writer (outside Punjab), Shiromani Panjabi Bal Literature Writer, Shiromani Panjabi Generalist, Shiromani Ragi, Dhadi, Poet, Panjabi Singer and Shiromani Panjabi Television/Radio/Theater/ Play/Actor/Director/Writer The Award. awards are recommended through the Punjab Languages Department and the State Government constitutes a State Advisory Board for

Assisting the Selection Process of these awards. The State Advisory Board consists of 32 members from the field of Literature, Art and Culture out of which 16 members are official members being from the Department of Education including the Minister for Education and also include representatives of various academic and literary bodies of State. The State Advisory Board is constituted every 3 years. The State Advisory Board was last constituted in the year 2008. The process of selection emanates from recommendations made by various Literary Bodies, Cultural Organizations, Literary Forums, Prominent Personalities apart from the in person nominations. These names are consolidated by the Director, Department of Languages. They are then forwarded by the Director being the Member Secretary of the Board as an agenda for being considered by the State Advisory Board. The recommendations of the Screening Committee are put up to the State Advisory Board which considers the name and makes a panel for consideration and conferring of these awards. The matter is thereafter finalized by the Minister of Education, State of Punjab. In the present case the awards have been finalized and conferred for the years 2007-2008. One award of Punjabi Sahit Rattan and 13 awards in different categories of Shiromani Panjabi Awards were finalized and conferred by the Hon'ble Chief Minister Punjab held on 08.08.2008.

2. That the petitioner has filed the present writ petition with a malafide intention. The petitioner does not have any literary back ground and is a busy body who has approach this Hon'ble Court nursing a grudge of non consideration for the impugned awards. Though the petitioner claims to be a self styled Director

of some video publication. His works have neither been recognized nor entered in the records of any of the literary associations or boards. The name of the petitioner was not recommended by any Literary Body, Cultural Organization or Forum and he even did not make any personal nomination for consideration for the said awards. On the face of the petitioner does not seems to have any interest in the field of the literature and is only seeking publicity through the present writ petition. It is the settled law that such persons should not be allowed to abuse the process of law and waste the precious time of the court by filing such petitions in the garb of public interest. The writ petition is liable to be dismissed on this short ground alone.

- 3. That the answering respondents are persons who have contributed in the field of Art and Literature. The brief description of the answering respondents in regard to their literary achievements is as under:
  - S. Jaswant Singh Kanwal (Respondent No.3) is writer of Repute who has written 32 Punjabi Novels, 12 compilation of short stories, many essays of important issues and has also authored a translation of popular literary piece Devdas. He has earlier been conferred the Sahit Academy Award Delhi, Shri Kartar Singh Dhaliwal Award, Sant Singh Sekhon award etc. He is also a member of a large number of literary bodies and organizations. He has been conferred the Shiromani Panjabi Sahitkar award.

Dalip Kaur Tiwana (Respondent no.4) Padma Shri is a M.A., Ph.D and has been employed as Professor in Punjabi, Dean Faculty of Languages, Punjabi University Patiala and is currently a Life Fellow of Punjabi University Patiala. She has 29

Novels, 7 Collections of Short Stories, Autobiography and Literary Autobiography 2 her credit. She has been honoured with UGC National Lectureship. Some of awards which have been conferred upon her are the Government of Punjab Award for the best book of Short Stories in 1960-1961, Sahit Academy Award in 1972, Ministry of Education and Social Welfare Award 1975, Nanak Singh Puraskar, Gurmukh Singh Musafir Award 1982 Canadian International Association of Punjabi Authors and Artists Award 1985, Shiromani Sahitkar Award 1987, Dhaliwal Award 1991, Best Novelist of the Decade 1980-1990 by Punjabi Academy Delhi, Nanjanagudu Thirumalamba Award Karnatka 1994, Wag Devi Award Calcutta 1998, Mata Sahib Kaur Award 1999, Kartar Singh Dhaliwal Life Time Achievement Award 2000, Sarsawti Sanman 2001 and was further conferred the Padma Shri by the Government of India in 2004.

Karnail Singh Thind (Respondent no.5) has worked in the post Graduate Department of Punjabi for 16 years before taking over as the Head of the Department. He has been the Reader, Professor and Head and Registrar of the Guru Nanak Dev University, Amritsar. He has been the Director of the Punjab State University, Text Book Board, Chandigarh, Senior Fellow of the Punjabi University and the Fellow of the Guru Nanak Dev University, apart from being the Life Fellow of the Punjabi University Patiala. The respondent was conferred the Senior Fellow Ship Award by the Department of Culture, Government of India. He also has credit the UGC Research Award 1971and has been a Convener, Member, Fellow and Chairman of various Academic Boards, Academies and Committees.

Shri Chotu Ram Moudgill (Respondent no.6) presently employed as the Director, Haryana Punjabi Sahit Academy, under the Government of Haryana at Panchkula. He has 18 books to his credit apart from 14 Translations and has edited over 13 publications. He has been awarded the Shiromani Kalamkar, Saravshresth Award, Balraj Sahni National Award, Vishwa Punjabi Sanman amongst other numerous awards. He has been credited for keeping alive the Punjabi Tradition in the State of Haryana.

Ravinder Kaur (Respondent no.7) is a M.A. Ph.D. and has been Head, Department of Sanskrit and Pali, Punjabi University, Patiala for the period of 1989-1992 and from the period 1998-2001. She further Head, Department of Persian Urdu & Arabic, Punjabi University, Patiala for a period May 2005-September 2005 and November 2006-April, 2007. Thereafter she became Head, Department of Foreign Languages, Punjabi University, Patiala for the period 2005-2007. Further Dean, Faculty of Languages, Punjabi University, Patiala 2005-2007. further Head, Department of Sanskrit and Pali, Punjabi University, Patiala, September 2007 onwards. Further Head, Department of Maharsi Valmiki Chair, Punjabi University, Patiala December 2005 onwards.

Dr. Jaswinder Singh (Respondent no. 9) who is credited with 13 publications and about 100 research papers apart from authoring a 21 books. He is further a recipient of Teja Singh Award, Nanak Singh Award, Teja Singh Award for poetry, Principal Sant Singh Sekhon Purskar, Dr. Daljit Singh Memorial Award, Award of Honour for contribution to Punjabi Criticism by

Punjabi Sahit Sabha California. He has been the Chairman of the Department of Punjabi, Punjabi University, Dean Alumni Relations, Punjabi University, Patiala. Junior Associate of All India Advance Institute Shimla and an Editor of Punjabi Folk Literature Section of the Children Encyclopedia.

It is apparent from the aforementioned facts that the answering respondents are fully deserving of the honour that has been conferred upon them by the State Government. The petitioner has made an effort to criticize the process of finalization of list of awardees. Serious allegations have been made in regard to integrity and morality of the answering respondents which are wholly misconceived. There is no challenge to the distinction achieved by the answering respondents on the basis of which their consideration for the awards has been made.

That the criteria for selection of awardees has been done in a totally bonafide and transparent manner. The aims and objectives of the State Advisory Board are centered around rendering advice to the Language Department, State of Punjab in various fields. The objectives of the Board as per the notification dated 05.11.2002 include recommendations in respect of providing grants to writers, artists or institutions, to evaluate literary books in Punjabi, Urdu, Hindi and Sanskrit and gave inputs for development of languages, especially the State Language i.e. Punjabi apart from recommending capable persons for Punjabi Sahit Shiromani Award and other Shiromani Awards. Earlier the persons who were apart of the State Advisory Board were required to resign in case their names were to be considered for the awards in question. However, this

practice led to the non consideration of many literary eminent people who were brought on the board or their resignation in event of their consideration. The State Advisory Board constituted on 18.02.2008 in its meeting held on 23.07.2008 considered the issue in depth and decided that the persons who are members of the Board but were nominated by the State Government for the award on account of their contribution in different fields of literature, the said member would leave the meeting at the time when his name is considered. It is pertinent to mention here that out of the total of 32 members of the State Advisory Board 10 were recommended for the awards and 8 were finally selected while 2 members who were recommended were not selected. None of these members participated in the proceedings when their name was considered against the category in which they were nominated. There is no malafide in nomination or selection during the process challenged by the petitioner.

5. That the recommendations were made by the Screening Committee wherein 6 names for each award were short listed. It is out of these 6 names that two names were finalized, one for each year for the conferring of the award. The Screening Committee consisted of 6 persons and the names were short listed out of total 280 names. The answering respondents did not participate in the concerned proceedings when their names were considered either at the time of screening or at the time of final decision. The Challenged to the conferring of these awards has caused great mental distress to the answering respondents who have made vast contribution in the field of literature and

art. The writ petition is thus totally misconceived and liable to be rejected.

### ON MERITS

- 1. The contents of this para of the petition are wrong and denied and it is submitted that the instant writ petition is not maintainable in its present form as no cause of action has arisen for the petitioner to file the writ petition.
- 2. The contents of this para of the petition are wrong and denied. Moreover the present writ petition has been filed by the petitioner in Public Interest whereas the petitioner is trying to redress his personal grievance of not having been nominated or selected for the awards that he has impugned. It is further submitted that That the claim of the petitioner that he is writer in English, Hindi and Punjabi is denied for want of knowledge. However it is wrong to suggest that the writers have selected themselves for the awards. The awards are recommended through the Punjab Languages Department and the State Government constitutes a State Advisory Board for Assisting the Selection Process of these awards. The State Advisory Board consists of 32 members from the field of Literature, Art and Culture out of which 16 members are official members being from the Department of Education including the Minister for Education and also include representatives of various academic and literary bodies of State. The State Advisory Board is constituted every 3 years and it was last constituted in year 2008. It is pertinent to mention here that out of the total of 32 members of the State Advisory Board 10 were recommended for

the awards and 8 were finally selected while 2 members who were recommended were not selected. None of these members participated in the proceedings when their name was considered against the category in which they were nominated. There is no malafide in nomination or selection during the process challenged by the petitioner.

- 3. That the contents of the para are matter of record.
- 4. That the contents of para No. 4 of the petition are admitted to the extent that the meeting was held on 21.07.2008 and rest of contents of the para are matter of record.
- 5. The contents of this para of the petition are wrong and denied however it is again reiterated her that that out of the total of 32 members of the State Advisory Board 10 were recommended for the awards and 8 were finally selected while 2 members who were recommended were not selected. None of these members participated in the proceedings when their name was considered against the category in which they were nominated. The factual position has been explained in preliminary submissions from para No. 1 to 5.
- 6. That the contents of this para are admitted to the extent that the amount of award was increased from Rs. 2.5 lacs to 5.00 lac and from 1.0 lac to 2.50 lac, for which the advisory board is fully competent. Rest of the contents of the para are wrong and denied as the awardees were selected purely on the basis of merit by the State Advisory Board in which the concerned person was not present. It is submitted that S. Jaswant Singh Kanwal and Dr. Dalip Kaur Tiwana are international

personalities. They have got National/International awards. Dr. Dalip Kaur Tiwana is recipient of Sahit Academy Award, Sarswati Award and Padamshri Awards. Advisory Board while considering the name of the awardees, kept in view their contribution in the field of literature and service of the language. It is further clarified that Chotu Ram Moudgil served the language Department till January 1997 as Assistant Director but since 1992 his permanent resident is in Kurukshetra. He is voter of Kurukshetra Constituency. Copy of the voter card issued on 20.12.1994 is annexed herewith as Annexure R-3/1. Further he was enrolled as an advocate of Kurukshetra Bar vide Identity card No. 22098 dated 25.04.1999. As also the copy of the ration card showing him a permanent resident of Kurukshetra is annexed herewith as Annexure R-3/2. He was appointed Director of Haryana Punjabi Sahitya Academy vide Haryana Government notification dated 27.04.2005 which clearly shows that he is resident of Haryana State for the last 15 years. Further he is Ex-officio member of the advisory board being director of the Haryana Punjabi Sahitya Academy. So far selection of the retiree of the department for Shiromani Sahitkar is concerned there are numerous precedents e.g. Principal Teja Singh, Shamsher Singh Ashok, Prof. Kirpal Singh Kasel, Prof. Piara Singh Padam & Prem Bhushan Goyal all were given these awards on the basis of their literary contributions.

7. The contents of this para of the petition are wrong and denied.

Sufficient reply to the contents of this para has already been given in the foregoing para of the written statement but however it is reiterated here that the petitioner has filed the present writ

petition with a malafide intention. The petitioner does not have any literary back ground and is a busy body who has approach this Hon'ble Court nursing a grudge of non consideration for the impugned awards. Though the petitioner claims to be a self styled Director of some video publication, his works have neither been recognized nor entered in the records of any of the literary associations or boards. The name of the petitioner was not recommended by any Literary Body, Cultural Organization or Forum and he even did not make any personal nomination for consideration for the said awards. On the face of the petitioner does not seems to have any interest in the field of the literature and is only seeking publicity through the present writ petition. It is the settled law that such persons should not be allowed to abuse the process of law and waste the precious time of the court by filing such petitions in the garb of public interest. The writ petition is liable to be dismissed on this short ground alone.

- 8. The contents of this para of the petition are wrong and denied, however it is submitted there is no rule to distribute the awards in the month of November. There are so many occasions when the awards were given on different months as the awards for the year 2001, 2002, 2003 and 2004 were distributed on 3rd December 2004 and awards for the year 2005 was distributed on 5.12.2005. The awards distributed on 08.08.2008 included awards for the year 2007 and 2008 and thus were distributed with considerable delay rather than in a hurry as alleged by the petitioner.
- 8(a). That contents of this para of the petition is admitted to the extent of legal submission as also to the extent that the

function was held on 8th August, 2008 in the Law Auditorium of Panjab University Chandigarh and Sh. J.S. Damdami had declined to receive the award. Rests of the contents of this para are wrong and declined para is wrong hence denied. Sufficient reply to the contents of this para has been given in the foregoing paras.

- 8(b). That the contents of this para of the petition is admitted to the extent of legal submission. Rests of the contents of this para are wrong and declined para is wrong hence denied. Sufficient reply to the contents of this para has been given in the foregoing paras.
- 8(c) to 8(e). The contents of this para of the petition are wrong and denied.

  - 9. The contents of this para of the petition are wrong and denied.

It is therefore respectfully prayed that present writ petition may kindly be dismissed with cost in favour of the answering respondent.

Civil Writ Petition under section 226 / 227 of the Constitution of India for the issuance of writ of mandamus to the official respondents not to distribute the awards to the unofficial respondents on 8<sup>th</sup> August, 2008, which is illegal, unconstitutional and against the principle of natural justice and liable to be set aside.

## Respectfully Showeth:

- That the petitioner is a citizen of India and the cause of action has also arisen within the jurisdiction of this Hon'ble Court, therefore, the petitioner is competent to invoke extraordinary jurisdiction under Articles 226 / 227 of the Constitution of India in public interest, as the petitioner is deeply connected with the field of Art and Literature.
- 2. That the petitioner is a writer in English, Hindi and Punjabi, associated with the Literary World for the last about three decades. And presently, the petitioner is Director, Update Video Publications and consultant Media Video Limited. The petitioner has published his books of English Poetry namely "Visions" in 1986 and thereafter "Nature's Nodes" in 1989. The Articles of the petitioner have been published in various newspapers and journals. Therefore, as a man of literature, the petitioner is deeply interested in the development of literature and art and especially the value system which the writers must uphold to be a role model in the society. So what has published in the newspapers regarding the award distribution and the greed of the writers by selecting themselves for the award has really distressed the petitioner. And finding no other option, the

petitioner is filing this petition so that a larger public interest be served.

- 3. That like earlier years, the Language Department of the Punjab Government also planned to distribute awards to the distinguished writers in Punjabi, Hindi, journalists and various other persons involved in the field Art and Literature. For this purpose, the Punjab Government constituted that Advisory Board, Language Department Punjab, 2008, consisting of 32 persons, the list of which is annexed here as Annexure P-1. And thereafter the Punjab Government constituted the Screening Committee of six persons, the names of those persons are mentioned in Annexure P-2.
- That after constituting the Advisory Board and the Screening Committee, the meeting was held on 21<sup>st</sup> July, 2008, for the purpose of short-listing the names of the Writers, Artists to whom the award was given for the year 2007-2008. Out of the total list of 234 writers of various languages, journalists and others, the Screening Committee selected 78 writers, the name of which are mentioned in Annexure P-3. In each of the 13 category, which are mentioned in this Annexure, the Screening Committee selected six persons out of which the selection was to be made by the Advisory Board.
- That the controversy as involved in the present writ petition, has arisen because so many improprieties have been committed while finalizing the list of the awardees by the Advisory Board. Unfortunately, all the awardees i.e. non official respondents were the members of the Advisory Board. And some of them were the members of the Screening Committee as well. For instance, Dr. Dalip Kaur Tiwana i.e. Respondent No. 4, was a member of the

Advisory Board, then member of the Screening Committee and lastly one of the awardees for rupees five lakh for Punjabi Sahit Shiromani Puraskar for the year 2007. Incidentally, all the nonofficial respondents who have been given awards were the members of the Advisory Board. This action of non-official respondents is basically against the basic principle of justice and fairness that nobody can be judge in his own case. However, this is what has happened in the present case and these respondents have unfortunately 'glorified' themselves with the award. Earlier, to the present award giving process, if any member's name was to be considered for the award, then that member used to resign from the Advisory Board. However, this time, all these well tested traditions were thrown to the winds and the non official respondents in a very indignified manner became part of the selection process of these awards and ultimately got themselves selected for the awards

That respondent No. 3 and 4 have been selected for the award of Punjabi Sahit Shiromani Puraskar for the year 2008 and 2007 respectively, the prize money for which was increased from 2.5 lakhs to 5.0 lakhs. Similarly, Dr. Dhanwant Kaur was a member of the Advisory Board, whose husband Dr. Jaswinder Singh i.e. respondent No. 9 has been selected for the award of *Shiromani Punjabi Lekhak / Punjab Aalochak*. The other serious impropriety, which has been committed is: that Sh. Chhotu Ram Maudgil, who retired as a Assistant Director from the Language Department, Punjab and presently is Director of Haryana Punjabi Sahityak Academy, Panchkula has also been wrongly and illegally selected for the award of *Shiromani Punjabi Sahityakar as a candidate from* outside Punjab. In fact, he belongs to Punjab and throughout served in the Language Department of Punjab, therefore, he was

not eligible to be considered under the category of this Shiromani Punjabi Sahityakar as from outside Punjab. Similarly, the other nonofficial respondents were members of the Advisory Board, 2008 and were selected for different awards by the same Advisory Board of which they were the members. The Hon'ble Supreme Court in the case of A.K. Kripak vs. Union of India AIR 1970 SC Page 150, clearly laid down that if a member of the Selection Board was himself a candidate and ultimately was selected for the post, was clearly against the principles of natural justice. The Hon'ble Supreme Court in that celebrated case, set aside the selection simply on the ground that the selected candidate was a member of the Selection Board, even though he did not attend the meeting of the selection board when his own name was being considered. However, in the present case, right from the membership of the Advisory Board, the Screening Committee and ultimately the selection of awards, these non official respondents to whom the awards has been given, attended all the proceedings which were necessary for the selection of the awardees.

7. That the present case is serious and would have grave repercussions because it relates to the men of Literature and Art, who are supposed to uphold higher values of probity and morality in the society in which they live. And if such people start stooping low, because of their personal greed, then the serious moral crisis are bound to arise in that society. And if the newsitems, which have been published regarding the whole affair of these award giving to the writers are read, which are annexed herewith as **Annexure P-4** and **P-5**, then the effect of such impropriety of the respondents becomes clear. A writer or an Artist is supposed to defend humanity, dignity, integrity, morality, goodness and the superior

mental spiritual nature of man and not to degrade the same by his own low conduct. In the present case all the awardees of the prize, given by the State of Punjab, have not behaved in the manner, in which a writer or an artist is supposed to behave. Their conduct is both against the moral values and the principles of natural justice, which is abhorrent to our concept of justice.

- 8. That earlier these awards used to be given in the month of November in the Language Bhawan, Patiala and the occasion was to be celebrated for more than a week and the distinguished writers and artists used to attend the same, but this year for the reasons best known to the authorities, the award giving ceremony is being held on 8<sup>th</sup> August, 2008 at Chandigarh. This is very surprising for all the writers and the intellectuals because the Government is acting in a great hurry.
- 9. That the writ of mandamus deserve to be issued on the following grounds:
  - I. That all the eight awardees who have been selected for the award to be given on 8<sup>th</sup> August, 2008, were the members of the Advisory Board which selected them for this award out of the list prepared by the Screening Committee. Incidentally, some of the awardees were both the members of the Screening Committee and the Advisory Board, which were primarily instrumental in selecting the name of such writers and artists to whom the award was to be given. Therefore, the process of selection of the names of the awardees is vitiated that all these eight awardees of the various prizes were judges in their own case and their action is against the basic principles of natural justice and fairness. Therefore,

writ of mandamus deserves to be issued on this ground alone, restraining the official respondents giving them these award on 8<sup>th</sup> August, 2008.

- II. That the conduct of the official respondents is also illegal and against the basic principles of natural justice, allowing the unofficial respondents to be part of the Advisory Board, which was to select the name of the awardees. The writ of mandamus stopping them to proceed with the illegal activity of giving the award deserve to be issued.
- 10. That the main law points which arises in this writ petition are as under:
  - i) Whether the conduct of the unofficial respondents being a judge in their own case is against the established principle of law of the Hon'ble Supreme Court or not?
  - ii) Whether the conduct of the official respondents is illegal and against the principles of natural or not?
- 11. That the petitioner have no other remedy except approaching this Hon'ble Court through the present writ petition, as all other remedies are to be ineffective.
- 12. That the petitioner had filed no other petition or revision in this Hon'ble Court or in the Hon'ble Supreme Court of India for seeking the same relief. That no other appeal or revision is pending. No Caveat has been filed.

It is therefore respectfully prayed that after summoning and perusing the record of the petitioner's case –

- i) writ of mandamus be issued not to give award to the non official respondents as they were members of the Advisory Board which selected them for the award;
- ii) any other order / direction be passed as this Hon'ble court deem fit in the facts and circumstances of the case;
- that during the pendency of the writ petition, the direction be issued that the award be not distributed on 8<sup>th</sup> August, 2008 in the interest of justice and fairplay;
- iv) issuance of advance notices to the respondents may kindly be dispensed with;
- v) filing of certified copies of Annexures may kindly be dispensed with;
- vi) cost of petition may kindly be awarded in favour of the petitioner and against the respondents.
